Concerning : Launching of GOFX Contract

Sehubungan dengan pengaturan tata laksana perdagangan Komoditi Emas dan Mata Uang Asing di Bursa Komoditi dan Derivatif Indonesia (BKDI), maka melalui Surat Edaran ini BKDI menetapkan hal-hal sebagai berikut:

In accordance with the rules on trading practice of gold and foreign exchange in the Indonesia Commodity and Derivatives exchange (ICDX), through this Circular ICDX stipulates the following matter:

1. Dengan telah disetujuinya Kontrak GOLDUD dan Mata Uang Asing ("**Kontrak GOFX**") oleh Bappebti berdasarkan surat persetujuan berikut ini:
 - a. Surat Bappebti No. 68/BAPPEBTI/SD/02/2018 tentang Persetujuan Perubahan Kontrak Gulir Harian Emas US Dollar (GOLDUD); dan
 - b. Surat Bappebti No. 67/BAPPEBTI/SD/02/2018 tentang Persetujuan Perubahan Kontrak Mata Uang Asing (FOREX).


1. Upon the approval of GOLDUD and Foreign Exchange Contract ("**GOFX Contract**") by CoFTRA pursuant to the following letter:
 - a. CoFTRA Letter No. 68/BAPPEBTI/SD/02/2018 on Approval of Amendment of US Dollar Gold Roll Contract (GOLDUD); and
 - b. CoFTRA Letter No. 67/BAPPEBTI/SD/02/2018 on Approval of Amendment of Foreign Currency Contract (FOREX).

maka Kontrak GOFX akan efektif diperdagangkan di BKDI pada 30 Juli 2018.

thus the GOFX Contract shall be effectively traded in ICDX on 30th July 2018.

2. Setiap dan seluruh Anggota Bursa yang ingin melakukan transaksi Kontrak GOFX wajib mematuhi dan melaksanakan transaksi sesuai dengan ketentuan Peraturan dan Tata Tertib BKDI, Peraturan dan Tata Tertib Indonesia Clearing House, Peraturan dan Tata Tertib Kontrak GOFX berikut peraturan-peraturan pelaksanaannya yang diterbitkan dari waktu ke waktu.
3. Bahwa dengan berlakunya Peraturan dan Tata Tertib Kontrak GOFX sebagaimana dimaksud dalam angka 1 diatas, maka ketentuan Peraturan dan Tata Tertib Kontrak GOLDUD dan Mata Uang Asing yang diterbitkan sebelum Surat Edaran ini dinyatakan dicabut dan tidak berlaku.

2. Any and all Exchange Member who wish to trade in GOFX Contract shall comply and perform transaction in accordance to the ICDX Rules, Clearing House Rules, GOFX Contract Rules together with their relevant implementing rules issued from time to time.
3. With the enactment of the GOFX Contract as set out in point 1 above, therefore the provisions contains in the GOLDUD and Foreign Exchange Contract Rules prior to the issuance of this Circular shall be ceased to effect.
