Kontrak Berjangka yang ada di PT Bursa Komoditi dan Derivatif Indonesia (“BKDI”) merupakan Kontrak Komoditas dunia yang ditransaksikan dalam lingkup domestik, sehingga dengan adanya libur di Negara asal, yakni Amerika Serikat maka pada hari Senin, 1 Januari 2024, Sesi Perdagangan ditiadakan.

The Futures Contracts in PT Indonesian Commodity and Derivatives Exchange (“ICDX”) are world commodity contracts which are transacted domestically, so that within the originating country’s holiday, namely in the US, then on Monday, 1st January 2024, which will be closed Trading Session.
