Kontrak Berjangka yang ada di PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") merupakan Kontrak Komoditas dunia yang mengacu pada komoditas dari suatu negara, sehingga dengan adanya libur Negara Asal, yakni Amerika Serikat, maka pada hari Jumat, 29 Maret 2024, Sesi Perdagangan ditiadakan.

The Futures Contracts in PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") are world commodity contracts which refer to the commodities of a country, so that within the originating country's holiday, namely in the United States of America, then on Friday, 29th March 2024, which will be closed Trading Session.
