The Futures Contracts in PT Indonesian Commodity and Derivatives Exchange ("ICDX") are world commodity contracts which are transacted domestically, so that within the originating country's holiday, namely in the US, then on Wednesday, 1st January 2025, which will be closed Trading Session.
