PT Bursa Komoditi dan Derivatif Indonesia (BKDI) dan PT Indonesia Clearing House (ICH) menetapkan ketentuan-ketentuan sebagai berikut:

PT Bursa Komoditi dan Derivatif Indonesia (ICDX) and PT Indonesia Clearing House (ICH) stipulate the terms as follows:

**I. BIAYA PENDAFTARAN DAN PELAPORAN TRANSAKSI SPA**

**I. REGISTRATION AND REPORTING FEE OF OTC TRANSACTION**

1. Biaya yang dimaksudkan adalah sebagai berikut:

1. The fee aforesaid shall be as follows:

Biaya Transaksi Kontrak SPA Berbasis Mata Uang US Dollar (USD)	USD 0.60 per Lot	USD 0.60 per Lot
Biaya Transaksi khusus untuk Kontrak Derivatif CFD Single Stock (mata uang IDR dan USD)	0.0375% dari Nilai Transaksi (per sisi)	0.0375% dari Nilai Transaksi (per sisi)

2. Biaya transaksi sebagaimana tersebut pada poin 1 belum termasuk Pajak Pertambahan Nilai (PPN) yang akan dibebankan kepada Peserta SPA dan Penyelenggara SPA sesuai dengan peraturan perpajakan yang berlaku di Indonesia.

2. The transaction fees as referred to in point 1 are excluding the Value Added Tax (PPN) which will be charged to OTC Participants and OTC Operators in accordance with the applicable tax regulations in Indonesia.
