**Concerning : Rollover Rate of GOFX**

Sehubungan dengan perdagangan Kontrak Mata Uang Asing (FOREX) dan Kontrak Gulir Harian Emas (GOLDUD), maka dengan ini PT Bursa Komoditi dan Derivatif Indonesia (BKDI) dan PT Indonesia Clearing House (ICH) menetapkan ketentuan biaya gulir sebagai berikut:

In accordance with the trading of Foreign Exchange Contract (FOREX) and Daily Gold Rollover Contract (GOLDUD), thus Indonesia Commodity and Derivatives Exchange (ICDX) and PT Indonesia Clearing House (ICH) stipulate rollover fee as follows:

2. Penerapan Tingkat Gulir merujuk pada Konvensi Pasar yaitu pembebanan 3x (tiga kali) pada hari Rabu dan pembebanan 1x (satu kali) selain hari Rabu di Hari dan Jam Perdagangan.
3. Mata uang yang digunakan pada Tingkat Gulir adalah mata uang USD.
4. Tanda negatif (-) menunjukkan BKDI menerima Tingkat Gulir.

## II. KETENTUAN LAIN

1. Bahwa dengan berlakunya Surat Edaran Bersama ini, maka Surat Edaran Bersama Nomor: 320/SEB/BKDI-ICH/II/2022 perihal Tingkat Gulir GOFX dan 323/SEB/BKDI-ICH/III/2022 perihal Tingkat Gulir Produk Baru GOFX (NZDCHF) dinyatakan tidak berlaku lagi.
2. Ketentuan dalam Surat Edaran Bersama ini berlaku efektif pada tanggal 1 April 2022.
3. BKDI dan ICH berhak untuk menyesuaikan tingkat margin setiap waktu tanpa pemberitahuan, menyesuaikan dengan fluktuasi pasar.
4. Ketentuan-ketentuan dalam Surat Edaran Bersama ini dapat diubah dari waktu ke waktu.

2. The Rollover Rate shall be applied to Market Convention namely the 3x (three times) charges will be carried out on Wednesday and the 1x (one time) charges will be carried out in non-Wednesday within the Trading Day and Hours.
3. The Rollover rate is using the USD currency.
4. The negative (-) mark means the ICDX receives the Rollover Rate.

## II. MISCELLANEOUS

1. On the effective date of this Joint Circular, the Joint Circular Number: 320/SEB/BKDI-ICH/II/2022 on Rollover Rate of GOFX and 323/SEB/BKDI-ICH/III/2022 Rollover Rate of New Product GOFX (NZDCHF) shall be ceased to effect.
2. The provisions set forth in this Joint Circular shall be effective on 1<sup>st</sup> April 2022.
3. ICDX and ICH reserves the right to adjust the margins at any time without notice subject to market volatility.
4. Provisions as referred to in this Joint Circular are subject to change from time to time.
