**Perihal** : Pemberitahuan Informasi terkait Surat Edaran BAPPEBTI Nomor 32/BAPPEBTI/SE/02/2022

**Concerning** : Information for Notification related to BAPPEBTI Circular Letter Number 32/BAPPEBTI/SE/02/2022

Sehubungan dengan adanya Surat Edaran Nomor 32/BAPPEBTI/SE/02/2022 tanggal 21 Februari 2022 tentang Penegasan Ketentuan Hanya Wakil Pialang Berjangka yang Berhak Berhubungan Langsung dengan Nasabah dan Calon Nasabah, maka dengan ini PT Bursa Komoditi dan Derivatif Indonesia (BKDI) menyampaikan hal-hal sebagai berikut:

Pursuant to the Circular Letter Number 32/BAPPEBTI/SE/02/2022 dated February 21<sup>st</sup>, 2022 regarding Provisions Affirmation of Futures Broker Representatives only that are Entitled to Deal Directly with Customers and Prospective Customers, hereby Indonesia Commodity and Derivatives Exchange (ICDX) convey as following:

**I. KETENTUAN JANGKA WAKTU**

**I. TERMS OF TIME**

1. Bahwa BAPPEBTI memberikan jangka waktu kepada Pialang Berjangka paling lambat 30 (tiga puluh) hari kerja untuk melakukan penyesuaian dan tidak mempekerjakan pihak selain yang telah memiliki izin sebagai Wakil Pialang Berjangka untuk berhubungan langsung dengan Nasabah atau Calon Nasabah.
2. Bahwa jangka waktu penyesuaian tersebut berakhir pada tanggal 5 April 2022 sehingga BAPPEBTI dapat mengenakan sanksi terhadap Pialang Berjangka yang melanggar ketentuan dalam Surat Edaran tersebut setelah tanggal 5 April 2022.
3. Berkenaan dengan poin 1 dan 2 tersebut di atas, kepada seluruh Pialang Berjangka anggota PT Bursa Komoditi dan Derivatif Indonesia (BKDI) agar segera melaksanakan ketentuan dalam Surat Edaran ini.

1. BAPPEBTI orders terms of time to Futures Broker not later than 30 (thirty) working days to make adjustments and not to employ parties other than those own license as Futures Broker Representatives to deal directly with Customers or Prospective Customers.
2. Such term of time that ends on April 5<sup>th</sup>, 2022 allowed BAPPEBTI to impose sanctions of Futures Brokers who violate the provisions in the said Circular Letter after April 5<sup>th</sup>, 2022.
3. With regards to points 1 and 2 above, herewith to all Futures Brokers as members of the Indonesia Commodity and Derivatives Exchange (ICDX), to immediately implement provisions in this Circular Letter.
