**Concerning : Expansion of the Daily Price  
Limit for CPOTR Futures  
Contracts**

Sehubungan dengan meningkatnya volatilitas harga pada pasar FCPO yang diperdagangkan di Bursa Malaysia Derivatives, serta dalam rangka menjaga kelancaran perdagangan dan proses pembentukan harga yang wajar pada Kontrak Berjangka Crude Palm Oil (CPOTR), bersama ini disampaikan hal-hal sebagai berikut:

Bursa menetapkan pelebaran rentang batas pergerakan harga harian (Daily Price Limit) untuk Kontrak Berjangka CPOTR.

Pelebaran rentang batas pergerakan harga harian tersebut dilakukan sebagai respons terhadap peningkatan volatilitas harga pada pasar referensi FCPO BMD yang berpotensi mempengaruhi pergerakan harga pada perdagangan Kontrak Berjangka CPOTR.

Adapun ketentuan perubahan rentang batas pergerakan harga harian adalah sebagai berikut:

**Rentang batas sebelumnya : ± 4 % dari harga SOBO.**

**Rentang batas baru : ± 6% dari harga SOBO.**

Ketentuan pelebaran rentang batas pergerakan harga harian tersebut berlaku terbatas hanya untuk Hari Perdagangan tanggal 12 Mei 2026.

Bursa akan terus melakukan pemantauan terhadap kondisi pasar, khususnya terhadap pergerakan harga pada pasar referensi FCPO BMD, dan dapat melakukan penyesuaian lebih lanjut apabila diperlukan.

In light of the increasing price volatility in the FCPO market traded on the Bursa Malaysia Derivatives (BMD), and in order to ensure the smooth operation of trading and the formation of fair prices for Crude Palm Oil Futures Contracts (CPOTR), we hereby announce the following:

The Exchange stipulates a wider range for the daily price limit for CPOTR Futures Contract.

The widening of the daily price limit was implemented in response to increased price volatility in the BMD FCPO reference market, which could potentially affect price movements in CPOTR futures trading.

The amendments to the daily price limits are as follows:

**Previous limit: ±4% of the SOBO price.**

**New limit: ± 6% of the SOBO price.**

The provisions regarding the expansion of the daily price limits is effective only on May 12<sup>th</sup>, 2026 Trading Day.

The Exchange will continue to monitor market conditions, particularly price movements in the BMD FCPO reference market, and may make further adjustments if necessary.
