The Futures Contracts in PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") are world commodity contracts which are transacted domestically, so that within the originating country's holiday, namely in the United States of America, then on Thursday, 28th November 2024 and Friday, 29th November 2024, will be Half Day Trading Session.
