The Futures Contracts in PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") are world commodity contracts which refer to the commodities of a country, so that within the originating country's holiday, namely in the United States of America, then on Friday 7th April 2023, which will be closed Trading Session.
