Kontrak Berjangka yang ada di PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") merupakan kontrak komoditas dunia yang ditransaksikan dalam lingkup domestik, sehingga dengan adanya libur Negara Asal, yakni di Amerika Serikat, maka pada hari Senin, 7 September 2020, Sesi Perdagangan diadakan Setengah Hari.

The Futures Contracts in PT Indonesian Commodity and Derivatives Exchange ("ICDX") are contracts of world commodity which are transacted domestically, so that within the originating country's holiday, namely in the United States of America, then on Monday, 7th September 2020, will be Half Day Trading Session.

I. SESI PERDAGANGAN SETENGAH HARI

I. HALF DAY TRADING SESSION

Pada hari Senin, 7 September 2020 berikut dibawah ini kontrak-kontrak Berjangka yang diperdagangkan di BKDI (terutama Produk GOFX) yang akan ditutup lebih cepat pada Pukul 23:59 WIB yaitu :

On Monday, 7th September 2020 the below are the future contracts on ICDX (especially GOFX Products) to be closed early at 23:59 WIB are:

1. Kontrak Gulir Harian Emas US Dolar (GOLDUD);
2. Kontrak Gulir Harian Emas Rupiah (GOLDID);
3. Kontrak Berjangka Minyak Mentah (COFR dan COFRMic);
4. Kontrak Berjangka Minyak Mentah AS (COFU10 dan COFU100);
5. Kontrak Gulir Harian Mata Uang Asing.

1. US Dollar Gold Daily Rollover Contract (GOLDUD);
2. Rupiah Gold Daily Rolling Contract (GOLDID)
3. Crude Oil Futures Contract (COFR dan COFRMic);
4. Crude Oil US Futures Contract (COFU10 and COFU100);
5. Daily Rollover Foreign Exchange Contract.

Dan sesi Perdagangan akan kembali normal pada hari Selasa, 8 September 2020

And Trading sessions will be back normal on Tuesday, 8th September 2020.
