Kontrak Berjangka yang ada di PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") merupakan Kontrak Komoditas dunia yang ditransaksikan dalam lingkup domestik, sehingga dengan adanya perubahan di Negara Asal, yakni Amerika Serikat, terkait dengan pergantian musim dari Musim Dingin ke Musim Panas, maka mulai tanggal 13 Maret 2023 hingga 6 November 2023, Sesi Perdagangan mengikuti *DayLight Saving Time*.

The Futures Contracts in PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") are world commodity contracts which are transacted domestically, so that with the changes in the Origin Country, namely in the United States of America, related to the change of season from Winter to Summer, then starting from March 13th 2023 to November 6th 2023, the Trading Sessions will be following Daylight Saving Time.
