Kontrak Berjangka yang ada di PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") merupakan Kontrak Komoditas dunia yang ditransaksikan dalam lingkup domestik, sehingga dengan adanya libur Negara Asal, yakni Amerika Serikat, maka pada hari Senin, 29 Mei 2023 Sesi Perdagangan diadakan Setengah Hari.

The Futures Contracts in PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") are world commodity contracts which are transacted domestically, so that within the originating country's holiday, namely in the United States of America, then on Monday 29<sup>th</sup> May 2023, will be Half Day Trading Session.

**I. SESI PERDAGANGAN SETENGAH HARI**
