The Futures Contracts in PT Indonesian Commodity and Derivatives Exchange ("ICDX") are world commodity contracts which are transacted domestically, so that within the originating country's holiday, namely in the US, then on Monday, 2nd January 2023, which will be closed Trading Session.

The provisions set forth in this circular letter shall be effective on Monday, 2nd January 2023.

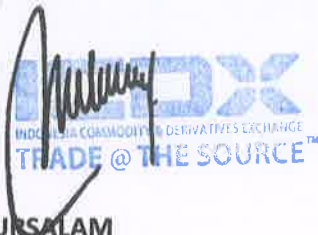
