Kontrak Berjangka yang ada di PT Bursa Komoditi dan Derivatif Indonesia (“**BKDI**”) merupakan Kontrak Komoditas dunia yang ditransaksikan dalam lingkup domestik, sehingga dengan adanya libur Negara Asal, yakni Amerika Serikat, maka pada hari Kamis, 27 November 2025 dan Jumat, 28 November 2025 Sesi Perdagangan ditutup lebih cepat.

The Futures Contracts in PT Bursa Komoditi dan Derivatif Indonesia (“**ICDX**”) are world commodity contracts which are transacted domestically, so that within the originating country’s holiday, namely in the United States of America, then on Thursday 27th November 2025 and Friday, 28th November 2025, the Trading Session will be closed earlier.

I. EARLY CLOSURE OF TRADING SESSION
