In accordance with the multilateral trading of GOFX, thus PT Indonesia Commodity and Derivatives Exchange (ICDX) and PT Indonesia Clearing House (ICH) stipulate the following:

I. PENGHENTIAN KUOTASI GOLDID

I. DEACTIVATION OF GOLDID QUOTATION

1. Terhitung efektif sejak tanggal 1 Oktober 2022, kuotasi penawaran harga jual dan harga beli untuk produk GOLDID tidak akan tersedia atau dinonaktifkan.
2. Seluruh Anggota BKDI-ICH wajib untuk menyesuaikan dengan SEB ini dan memastikan tidak ada posisi terbuka nasabah pada tanggal SEB ini efektif.

1. Effective as of October 1st, 2022, quotes for selling and buying prices for GOLDID products will not be available or will be deactivated.
2. All BKDI- ICH Members are obliged to comply with this SEB and ensure that there are no open customer positions on the effective date of this SEB.
