Kontrak Berjangka yang ada di PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") merupakan Kontrak Komoditas dunia yang ditransaksikan dalam lingkup domestik, sehubungan adanya libur di negara asal, yaitu Amerika Serikat karena adanya US Christmas Day, dengan ini kami sampaikan informasi mengenai penyesuaian jadwal Sesi Perdagangan pada tanggal 24-25 Desember 2024, sebagai berikut:

The Futures Contracts in PT Indonesian Commodity and Derivatives Exchange ("ICDX") are world commodity contracts which are transacted domestically, so that within the originating country's holiday, namely in the United States due to US Christmas Day, we hereby inform of the adjustment to the trading session schedule for December 24-25, 2024, as follows:

I. SESI PERDAGANGAN

- 1. Sesi Perdagangan Setengah Hari**
Untuk produk Gold dan Oil, Sesi Perdagangan pada hari Selasa, 24 Desember 2024 akan berlangsung setengah hari.
- 2. Penutupan Sesi Perdagangan**
Untuk produk Gold, Oil dan Forex, Sesi Perdagangan akan ditiadakan pada hari Rabu, 25 Desember 2024.
- 3. Sesi Perdagangan Kembali Normal**
Sesi Perdagangan Kembali normal pada hari Kamis, 26 Desember 2024.

I. TRADING SESSION

- 1. Half-Day Trading Session**
For Gold and Oil products, the Trading Session on Tuesday, December 24, 2024, will be a half-day trading session.
- 2. Close of Trading Session**
For Gold, Oil and Forex products, the Trading Session will be closed on Wednesday, December 25, 2024.
- 3. Trading Session Return to Normal**
Trading Session will return to normal on Thursday, December 26, 2024.
