Kontrak Berjangka yang ada di PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") merupakan Kontrak Komoditas dunia yang ditransaksikan dalam lingkup domestik, sehingga dengan adanya libur Negara Asal, yakni Amerika Serikat, maka pada hari Senin, 19 Januari 2026 Sesi Perdagangan akan ditutup lebih cepat.

The Futures Contracts in PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") are world commodity contracts which are transacted domestically, so that within the originating country's holiday, namely in the United States of America, then on Monday 19th January 2026, the trading session will be closed earlier.
