Futures contracts in PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") are the worldwide commodity contracts which are transacted within the domestic scope so as there will be a public holiday in the country of origin, which is the United States of America, due to the Good Friday, the trading sessions will be adjusted.
