<b>Perihal</b>	<b>: Perubahan Struktur Biaya Transaksi REC Tipe Kepesertaan Pemasok</b>	<b>Subject</b>	<b>: Amendment to REC Transaction Fee Structure for Supplier Membership Type</b>

Melalui Surat Edaran Bersama Ini ("SEB"), PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") dan PT Indonesia Clearing House ("ICH") menerbitkan SEB yang menetapkan perubahan ketentuan mengenai struktur biaya transaksi *Renewable Energy Certificate* ("REC") Tipe Kepesertaan Pemasok sebagai berikut:

Through this Joint Circular Letter, PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") and PT Indonesia Clearing House ("ICH") issue a Joint Circular Letter which enact amendment to the Renewable Energy Certificate ("REC") fee structure for Supplier Membership Type as follows:

| <p><b>I. PERUBAHAN STRUKTUR BIAYA TRANSAKSI REC</b></p> <p>1. Mengubah besaran Biaya Transaksi Pasar Reguler menjadi <b>Rp. 1.000 / MWh</b> dan Biaya Transaksi Pasar Premium menjadi <b>Rp. 1.250 / MWh</b>.</p> <p>2. Dengan berubahnya Biaya Transaksi Pasar Reguler dan Biaya Transaksi Pasar Premium, sebagaimana dimaksud pada butir 1 di atas, maka Struktur Biaya Transaksi REC Tipe Kepesertaan Pemasok adalah sebagai berikut:</p> | <p><b>I. AMENDMENT TO REC TRANSACTION FEE STRUCTURE</b></p> <p>1. Amend the amount of Regular Market Transaction Fee to <b>IDR 1,000 / MWh</b> and Premium Market Transaction Fee to <b>IDR 1,250 / MWh</b>.</p> <p>2. With the amendment to the Regular Market Transaction Fee and Premium Market Transaction Fee, as referred to in point 1 above, the REC Transaction Fee Structure for Supplier Membership Type is as follows:</p> |

Biaya Transaksi Pasar Reguler / <i>Transaction Fee on Regular Market</i>	IDR 1,000/MWh
Biaya Transaksi Pasar Premium / <i>Transaction Fee on Premium Market</i>	IDR 1,250/MWh
Biaya Retirement I-REC Standard ( <i>Evident Registry</i> ) / <i>Retirement Fee I-REC Standard (Evident Registry)</i>	USD 0.11/MWh

**Keterangan:**

- a. Biaya Keanggotaan Tahunan:  
Biaya Keanggotaan Tahunan didasarkan pada tahun kalender keanggotaan.
  - b. Biaya *retirement* akan diteruskan secara langsung ke I-REC *Standard (Evident Registry)*.
  - c. Biaya Keanggotaan Tahunan dan Biaya Transaksi yang dibebankan belum termasuk pajak berdasarkan ketentuan perpajakan di Republik Indonesia.
3. Dengan diterbitkannya SEB ini, maka SEB No. 407/SEB/BKDI-ICH/I/2025 tentang Struktur Biaya Transaksi REC Tipe Kepesertaan Pemasok dicabut dan dinyatakan tidak berlaku lagi.

**II. KETENTUAN LAIN**

1. Ketentuan-ketentuan dalam Surat Edaran ini dapat diubah dari waktu ke waktu.
2. Ketentuan dalam Surat Edaran ini berlaku efektif pada 1 Februari 2026.

**Remarks:**

- a. Annual Membership Fee:  
The Annual Membership Fee is based on the membership calendar year.
  - b. Retirement fee will be forwarded directly to the I-REC Standard (Evident Registry).
  - c. The Annual Membership Fee and Transaction Fee imposed are exclusive of taxes in accordance with the taxation regulations in Republic of Indonesia.
3. With the issuance of this Joint Circular, the Joint Circular No. 407/SEB/BKDI-ICH/I/2025 on REC Transaction Fee Structure for Supplier Membership Type is revoked and deemed invalid.

**II. MISCELLANEOUS**

1. Provisions referred to in this Circular are subject to change from time to time.
2. The provisions in this Circular shall become effective on 1<sup>st</sup> February 2026.
