Sehubungan dengan sedang dilakukannya penyesuaian pada Spesifikasi Kontrak Berjangka CPOTR terhadap ketentuan-ketentuan perdagangan kontrak fisik CPO yang diselenggarakan oleh PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") dan PT Indonesia Clearing House ("ICH"), dengan ini BKDI dan ICH menetapkan ketentuan-ketentuan sebagai berikut:

In connection with adjustments being made to the CPOTR Futures Contract Specifications against the terms of CPO physical contract trading facilitated by PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") and PT Indonesia Clearing House ("ICH"), BKDI and ICH hereby stipulate the terms as follows:

**I. PENANGGUHAN PERDAGANGAN KONTRAK BERJANGKA CPOTR**

1. Terhitung sejak tanggal efektif surat edaran ini, perdagangan Kontrak Berjangka CPOTR ditangguhkan untuk dilakukan penyesuaian terhadap ketentuan-ketentuan perdagangan kontrak fisik CPO yang diselenggarakan oleh BKDI.
2. Penangguhan Kontrak Berjangka CPOTR berlaku sampai dengan revisi penyesuaian sebagaimana dimaksud poin 1 di atas telah mendapatkan persetujuan dari Badan Pengawas Perdagangan Berjangka Komoditi.

**I. SUSPENSION OF CPOTR FUTURES CONTRACT TRADING**

1. Commencing from the effective date of this circular, trading of CPOTR Futures Contracts is suspended to allow adjustments to the trading conditions for physical CPO contracts held by BKDI.
2. The suspension of CPOTR Futures Contract is applied until the revised adjustments as referred to in point 1 above have received approval from the Commodity Futures Trading Supervisory Agency.

**II. KETENTUAN LAIN**

1. Ketentuan dalam Surat Edaran Bersama ini akan berlaku efektif pada tanggal 24 Oktober 2023
2. Ketentuan-ketentuan dalam Surat Edaran Bersama ini dapat diubah dari waktu ke waktu.

**II. MISCELLANEOUS**

1. The provisions set forth in this Joint Circular shall be effective on 24 October 2023.
2. Provisions as referred to in this Joint Circular are subject to change from time to time.
