Concerning : Notification of GOFX Product Rollover Rate Implementation Changes

Sehubungan dengan perdagangan Kontrak Mata Uang Asing (FOREX) dan Kontrak Gulir Harian Emas (GOLDUD), maka dengan ini PT Bursa Komoditi dan Derivatif Indonesia (BKDI) dan PT Indonesia Clearing House (ICH) menetapkan ketentuan biaya gulir sebagai berikut:

In accordance with the trading of Foreign Exchange Contract (FOREX) and Daily Gold Rollover Contract (GOLDUD), thus PT Bursa Komoditi dan Derivatif Indonesia (ICDX) and PT Indonesia Clearing House (ICH) stipulate rollover fee as follows:

I. TINGKAT GULIR

1. Terhitung sejak Tanggal Efektif SEB ini, produk **GOFX Mini** dan **GOFX Mikro** untuk Kontrak Mata Uang Asing (FOREX) dan Kontrak Gulir Harian Emas (GOLDUD) dikenakan biaya tingkat gulir.
2. Mata uang yang digunakan pada Tingkat Gulir adalah mata uang USD.
3. Informasi nilai tingkat gulir sebagaimana dimaksud dalam poin 1 akan disediakan melalui situs web resmi ICH yaitu <https://www.ich.co.id/news/111>.
4. Nilai tingkat gulir akan diperbaharui setiap akhir minggu pada situs web ICH, sehingga tidak diterbitkan lagi SEB untuk setiap perubahan tingkat gulir.
5. Informasi nilai tingkat gulir GOFX Mini dan GOFX Mikro melalui situs web tersebut berlaku terhitung sejak Tanggal Efektif SEB ini.

II. KETENTUAN LAIN

I. ROLLOVER RATE

1. As of the Effective Date of this SEB, GOFX Mini and GOFX Micro products for Foreign Exchange Contract (FOREX) and Gold Daily Rollover Contract (GOLDUD) are charged with rollover rate fees.
2. The Rollover rate is using the USD currency.
3. Information on the rollover rate as referred to in point 1 will be provided through the official ICH website, namely <https://www.ich.co.id/news/111>.
4. The rollover rate value will be updated every weekend on the ICH website, therefore the SEB for any change on rollover rate shall be no longer issued.
5. Information on the value of GOFX Mini and GOFX Micro rollover rates via the website is applied starting from the Effective Date of this SEB.

II. MISCELLANEOUS

1. Surat Edaran Bersama yang mengatur tentang Tingkat Gulir GOFX yang masih berlaku tetap efektif sampai dengan tanggal **2 April 2023**.
 2. Tanggal Efektif Surat Edaran Bersama adalah terhitung sejak tanggal **3 April 2023**.
 3. BKDI dan ICH berhak untuk menyesuaikan tingkat gulir setiap waktu tanpa pemberitahuan, menyesuaikan dengan kondisi pasar.
 4. Ketentuan-ketentuan dalam Surat Edaran Bersama ini dapat diubah dari waktu ke waktu.
1. Joint Circulars regulating the GOFX Rollover Rate that are still valid shall remain effective until **April 2nd, 2023**.
 2. The effective date of this Joint Circular is **3rd April 2023**.
 3. ICDX and ICH reserves the right to adjust the rollover rate at any time without notice subject to market condition.
 4. Provisions as referred to in this Joint Circular are subject to change from time to time.
