Kontrak Berjangka yang ada di PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") merupakan Kontrak Komoditas dunia yang ditransaksikan dalam lingkup domestik, sehingga dengan adanya libur Negara Asal, yakni Amerika Serikat, maka pada hari Jumat, 3 Juli 2026 Sesi Perdagangan akan ditutup lebih awal.

The Futures Contracts in PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") are world commodity contracts which are transacted domestically, so as there will be a public holiday in the country of origin, namely in the United States of America, then on Friday, 3rd July 2026, the Trading Session will be closed earlier.

I. EARLY TRADING SESSION CLOSURE
