The Futures Contracts in PT Indonesian Commodity and Derivatives Exchange ("ICDX") are world commodity contracts which are transacted domestically, so that within the originating country's holiday, namely in the United States of America, then on Thursday, 26th November 2020 and Friday, 27th November 2020, will be Half Day Trading Session.
