Sehubungan dengan perdagangan multilateral produk-produk GOFX, maka dengan ini PT Bursa Komoditi dan Derivatif Indonesia (BKDI) dan PT Indonesia Clearing House (ICH) menetapkan sebagai berikut:

In accordance with the multilateral trading of GOFX, thus PT Indonesia Commodity and Derivatives Exchange (ICDX) and PT Indonesia Clearing House (ICH) stipulate the following:

I. DEAKTIVASI PERDAGANGAN BEBERAPA PRODUK GOFX

1. Terhitung efektif sejak tanggal surat ini, kuota penawaran harga jual dan harga beli untuk kontrak USDINR, USDINRMic, USDKRW, USDKRWMic, USDMYR, USDMYRMic, USDRUB dan USDRUBMic tidak akan tersedia atau dilakukan deaktivasi.
2. Seluruh Anggota BKDI-ICH wajib untuk menyesuaikan dengan SEB ini dan memastikan tidak ada posisi terbuka nasabah pada tanggal SEB ini efektif.

II. KETENTUAN LAIN

1. Ketentuan dalam Surat Edaran Bersama ini berlaku efektif pada tanggal surat edaran ini.
2. Ketentuan-ketentuan lainnya yang telah diterbitkan oleh BKDI dan ICH yang berkaitan dengan kontrak produk USDINR, USDINRMic, USDKRW, USDKRWMic, USDMYR, USDMYRMic, USDRUB dan USDRUBMic dianggap tidak berlaku atau dicabut dengan SEB ini.

I. DEACTIVATION OF TRADING OF CERTAIN PRODUCTS ON GOFX

1. Effective as of date of this SEB, quotation for selling and buying prices for GOFX products: USDINR, USDINRMic, USDKRW, USDKRWMic, USDMYR, USDMYRMic, USDRUB, and USDRUBMic will not be available or deactivated.
2. All BKDI- ICH Members are obliged to comply with this SEB and ensure that there are no open customer positions on the effective date of this SEB.

II. MISCELLANEOUS

1. The provisions set forth in this Joint Circular shall be effective on date of this Circular Letter.
2. Other provisions that have been issued by BKDI and ICH relating to USDINR, USDINRMic, USDKRW, USDKRWMic, USDMYR, USDMYRMic, USDRUB dan USDRUBMic product contracts are deemed invalid or revoked by this SEB.
