Perihal : Biaya Transaksi Emas Digital Penyepadanan Di luar Bursa	Concerning : Digital Gold Transaction Fees Off Exchange

Sehubungan dengan pelaksanaan Transaksi Emas Digital Penyepadanan di luar Bursa, maka PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") dan PT Indonesia Clearing House ("ICH") menetapkan sebagai berikut:

In regard with the implementation of Digital Gold Transaction Off Exchange, then PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") and PT Indonesia Clearing House ("ICH") stipulate as follows :

I. BIAYA TRANSAKSI

I. TRANSACTION FEES

Melalui SEB ini maka biaya transaksi Emas Digital ditentukan sebagai berikut :

Through this SEB, the Digital Gold transaction fee are determined as follows :

Degresif Biaya Transaksi <i>Degressive Transaction fees</i>	Transaksi Beli <i>Buy Transaction</i>	Transaksi Jual <i>Sell Transaction</i>
> 50 Miliar	0.05%	Free
Rp 10 Miliar - Rp 50 Miliar	0.10%	Free
Rp 5 Miliar - Rp 10 Miliar	0.25%	Free
Rp 1 Miliar - Rp 5 Miliar	0.35%	Free
< 1 Miliar	0.50%	Free

1. Biaya transaksi tersebut hanya berlaku untuk transaksi Pembelian (buy).
2. Biaya transaksi sebagaimana tersebut pada poin 1 belum termasuk Pajak Pertambahan Nilai (PPN) sebesar 11%.

1. The transaction fee is only applicable for Purchase transactions.
2. The transaction fees as referred to in point 1 does not include the Value Added Tax (PPN) in the amount of 11%.
