<b>Perihal</b> : Biaya Transaksi Akumulatif Peserta Komersial di Pasar Murabahah Komoditi Syariah	<b>Concerning</b> : Accumulative Transaction Fees for Commercial Participants in the Sharia Commodity <i>Murabaha</i> Market

Sehubungan dengan penyesuaian biaya transaksi akumulatif di Pasar Murabahah Komoditi Syariah, maka melalui Surat Edaran Bersama ("SEB") ini, PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") dan PT Indonesia Clearing House ("ICH") menetapkan ketentuan-ketentuan sebagai berikut:

In connection with adjustment to the accumulative transaction fees in the Sharia Commodity *Murabaha* Market, through this Joint Circular, *PT Bursa Komoditi dan Derivatif Indonesia* ("BKDI") and *PT Indonesia Clearing House* ("ICH") stipulate the following provisions:

**I. BIAYA TRANSAKSI AKUMULATIF**

1. Biaya transaksi akumulatif Peserta Komersial di Pasar Murabahah Komoditi Syariah adalah sebagai berikut:

**I. ACCUMULATIVE TRANSACTION FEES**

1. The accumulative transaction fees for Commercial Participants in the Sharia Commodity *Murabaha* Market are as follows:

2. Biaya transaksi, sebagaimana dimaksud pada poin 1, belum termasuk Pajak Pertambahan Nilai ("PPN") yang akan dibebankan kepada Peserta Komersial sesuai dengan peraturan perpajakan yang berlaku di Indonesia.

2. The transaction fees, as referred to in point 1, are exclusive of the Value Added Tax ("VAT") which will be charged to the Commercial Participants in accordance with the prevailing tax laws and regulations in Indonesia.

3. ICH akan mengirimkan faktur di akhir bulan transaksi atau selambat-lambatnya 7 (tujuh) hari kerja di awal bulan berikutnya.
  4. Peserta Komersial wajib membayar biaya transaksi paling lambat 10 (sepuluh) hari kerja setelah faktur diterima oleh Peserta Komersial.
  5. Dengan diterbitkannya SEB ini, maka SEB BKDI dan ICH Nomor 376/SEB/BKDI-ICH/IV/2023 tentang Biaya Transaksi Akumulatif Peserta Komersial di Pasar Murabahah Komoditi Syariah dicabut dan dinyatakan tidak berlaku.
3. ICH will send an invoice at the end of the transaction month or no later than 7 (seven) working days at the beginning of the following month.
  4. The Commercial Participants must pay the transaction fee no later than 10 (ten) working days after the invoice is received by the Commercial Participants.
  5. With the issuance of this Joint Circular, the ICDX and ICH Joint Circular Number 376/SEB/BKDI-ICH/IV/2023 on Accumulative Transaction Fees of Commercial Participant in the Sharia Commodity Murabahah Market is revoked and declared invalid.

## II. KETENTUAN LAIN

1. Surat Edaran Bersama ini akan berlaku efektif pada tanggal 1 Agustus 2025.
2. Ketentuan-ketentuan dalam Surat Edaran Bersama ini dapat diubah dari waktu ke waktu.
