Kontrak Berjangka yang ada di PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") merupakan Kontrak Komoditas dunia yang ditransaksikan dalam lingkup domestik, sehingga dengan adanya perubahan di Negara Asal, yakni Amerika Serikat, terkait dengan pergantian musim dari Musim Panas ke Musim Dingin, maka mulai tanggal 04 November 2024 hingga 9 Maret 2025, Sesi Perdagangan mengikuti *DayLight Saving Time*.

The Futures Contracts in PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") are world commodity contracts which are transacted domestically, so that with the changes in the Origin Country, namely in the United States of America, related to the change of season from Summer to Winter, then starting from November 4<sup>th</sup> 2024 to March 9<sup>th</sup> 2025, the Trading Sessions will be following Daylight Saving Time.

**I. PERUBAHAN SESI PERDAGANGAN**

I. Sehubungan dengan akan berakhirnya jam perdagangan yang mengikuti periode *Daylight Saving Time* di AS, mulai hari Senin, 04 November 2024 sampai dengan Minggu, 9 Maret 2025, sesi perdagangan akan kembali normal dan kontrak-kontrak yang diperdagangkan di BKDI (terutama produk GOFX) menjadi sebagai berikut:

**I. TRADING SESSION CHANGES**

I. In relation to the end of Trading Hours following the Daylight Saving Time Period in US, from Monday, November 4<sup>th</sup> 2024 to Sunday, March 9<sup>th</sup> 2025, the trading session will return to normal and contracts traded on the ICDX (especially GOFX products) will be as follows:
