I. SESI PERDAGANGAN SETENGAH HARI

Sehubungan dengan adanya **US Labor Day** pada hari Senin 5 September 2022, maka sesi perdagangan Kontrak-Kontrak yang diperdagangkan di BKDI (terutama produk GOFX) akan menjadi sebagai berikut:

The Futures Contracts in PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") are world commodity contracts which are transacted domestically, so that within the originating country's holiday, namely in the United States of America, then on Monday 5th September 2022, will be Half Day Trading Session.
