Dalam rangka pelaksanaan kewajiban keuangan keanggotaan, PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") menetapkan jadwal pembayaran kewajiban anggota sebagai berikut:

For the implementation of membership financial obligations, then the Indonesia Commodity and Derivatives Exchange ("ICDX") determine the schedule for payment of member obligations as follows:

**I. KETENTUAN PEMBAYARAN**

**I. PAYMENT TERMS**

Pembayaran Invoice wajib dilakukan oleh Anggota dalam periode waktu sebagaimana yang ditetapkan. Segala bentuk Invoice yang dikirimkan BKDI kepada anggota wajib diselesaikan dalam waktu sebagaimana ditentukan dalam Surat Edaran sebagai berikut:

Invoice payments must be made by Members within the time period as stipulated. All forms of Invoice sent by ICDX to members must be completed within the time period as stipulated in this Circular Letter below:

| (5) Biaya Pengaktifan Kembali wajib dibayarkan paling lambat dalam waktu 14 (empat belas) hari kerja. | (5) Activation Fee must be paid no later than 14 (fourteen) working days.             |
| (6) Iuran Bulanan dibayarkan paling lambat pada tanggal 20 (dua puluh) setiap bulannya.               | (6) Monthly Fee is paid no later than the 20 <sup>th</sup> (twentieth) of each month. |

Apabila pembayaran biaya dan kewajiban keuangan sebagaimana diatur di atas jatuh pada hari libur bank-bank di Indonesia, maka pembayaran akan dilakukan pada hari kerja setelahnya.

Should the payment of fee and financial obligations as stipulated above falls on the date where the banks in Indonesia are close due to holidays, therefore payment shall be transferred on the next business day.

Dengan diberlakukannya kebijakan baru yang tertera di atas tersebut, maka dengan ini akan menyebabkan penyesuaian terhadap Jadwal Pembayaran Invoice dan Iuran Bulanan yang ditetapkan oleh BKDI dan ICH.

Whereas with the enactment of the new policies listed above, it will hereby cause adjustments to the Invoice Payment Schedule stipulated by the ICDX and ICH.
