**Concerning : Stipulation of Indonesia
Clearing House (ICH) Rules and
Regulations (Rules)**

Sehubungan dengan pengaturan tata laksana kliring dan penjaminan penyelesaian transaksi di Lembaga Kliring Indonesia (ICH), maka melalui Surat Edaran ini ICH menetapkan hal-hal sebagai berikut:

In connection with the rules on clearing and settlement guarantee of transaction practice in the Indonesia Clearing House (ICH), through this Circular ICH stipulates the following matter:

1. Revisi dan harmonisasi Peraturan Tata Tertib BKDI ("PTT ICH") telah mendapatkan persetujuan dari Bappebti berdasarkan Surat Nomor 139/BAPPEBTI/SD/05/2018 tertanggal 31 Mei 2018.
 2. PTT ICH memuat pengaturan Perdagangan Berjangka Komoditi, Penyaluran Amanat Nasabah ke Bursa Luar Negeri (PALN), Sistem Perdagangan Alternatif (SPA) dan Pasar Fisik.
 3. Setiap dan seluruh Anggota Kliring wajib mematuhi dan melaksanakan hak dan kewajibannya berdasarkan PTT ICH.
 4. Ketentuan dalam Surat Edaran ini berlaku efektif pada tanggal ditetapkannya Surat Edaran ini.
 5. Bahwa dengan berlakunya PTT ICH maka ketentuan yang tercantum dalam Peraturan dan Tata Tertib ICH sebelum Surat Edaran ini diterbitkan dinyatakan dicabut dan tidak berlaku.
 6. Ketentuan-ketentuan dalam Surat Edaran ini dapat diubah dari waktu ke waktu.
1. Revision and harmonisation of ICH Rules and Regulations ("ICH Rules") have been approved by CoFTRA based on Letter Number 139/BAPPEBTI/SD/05/2018 dated May 31st, 2018.
 2. ICH Rules contains provisions on Commodity Futures Trading, Customer Order Routing to Overseas Exchange, Alternative Trading System and Physical Market.
 3. Any and all Clearing Member is obliged to comply with and perform their rights and obligations in accordance to the ICH Rules.
 4. The provisions set forth in this Circular shall be effective on the date of stipulation.
 5. With the enactment of the ICH Rules therefore the provisions contained in the previous ICH Rules and Regulations prior to the issuance of this Circular shall be ceased to effect.
 6. Provisions as referred to in this Circular are subject to change from time to time.
