Sehubungan dengan Surat Edaran yang diterbitkan Bursa *Hong Kong Exchange* dengan nomor surat MO/DT/080/19 terkait dengan perubahan Jam Perdagangan Indeks Hang Seng, PT Bursa Komodi dan Derivatif Indonesia ("BKDI") bersama dengan PT Indonesia Clearing House ("ICH") melakukan perubahan Jam Perdagangan Indeks Hang Seng khususnya pada Sesi Perdagangan Setelah Jam Kerja, yang akan berlaku efektif bagi Anggota Bursa dan Anggota Kliring sebagai berikut:

In connection with the Circular Letter issued by Hong Kong Exchange number MO/DT/080/19 regarding to the changes of Hang Seng Index Trading Hours, PT Indonesia Commodity & Derivatives Exchange ("ICDX") together with PT Indonesia Clearing House ("ICH") stipulate the changes of Hang Seng Index Trading Hours especially for the Afteroffice Hours Trading Session that shall be effectively implemented to Exchange Member and Clearing Member as follows:
