Sehubungan dengan transaksi perdagangan GOFX, maka dengan ini Bursa Komoditi dan Derivatif Indonesia ("**Bursa**") bersama dengan *Indonesia Clearing House* ("**Lembaga Kliring**") menetapkan hal-hal sebagai berikut:

In connection with GOFX trading transaction, thus Indonesia Commodity and Derivatives Exchange (the "**Exchange**") together with Indonesia Clearing House ("**Clearing House**") stipulate the following provisions:

**I. SKEMA *REBATE***

1. Bursa dan Lembaga Kliring sepakat untuk mengenakan skema *Rebate* kepada semua Anggota Bursa dan/atau Anggota Kliring ("**Anggota**") baik Pialang Berjangka maupun Pedagang Berjangka yang melakukan transaksi GOFX sejak 31 Januari 2019 sampai 31 Maret 2019.
2. Skema *Rebate* yang dikenakan kepada semua Anggota sebagai berikut:
  - a. biaya transaksi sebesar USD 18 sen/lot; dan
  - b. skema *Rebate* ini berlaku untuk semua produk GOFX.

**I. REBATE SCHEME**

1. The Exchange and Clearing House agreed to apply the Rebate scheme to all Exchange Members and/or Clearing Members ("**Member**") which is Futures Broker and Futures Trader who conducted GOFX transaction from 31<sup>st</sup> January 2019 until 31<sup>st</sup> March 2019.
2. Rebate Scheme which applies to all Members are as follows:
  - a. transaction fee of USD 18 cents/lot; and
  - b. this Rebate scheme applies to all products of GOFX.

**II. KETENTUAN LAIN**

1. Ketentuan dalam Surat Edaran Bersama ini berlaku efektif sejak tanggal ditetapkan.
2. Dengan efektifnya Surat Edaran ini, maka Surat Edaran Bersama No. 140/SEB/BKDI-ICH/XII/2018 dicabut dan dinyatakan tidak berlaku.

**II. MISCELLANEOUS**

1. The provisions set forth in this Joint Circular shall be effective on the date of stipulation.
2. With the effectiveness of this Joint Circular, hence Joint Circular Number 140/SEB/BKDI-ICH/XII/2018 is revoked and cease to effect.

3. Ketentuan-ketentuan dalam Surat Edaran Bersama ini dapat diubah dari waktu ke waktu.
3. Provisions as referred to in this Joint Circular are subject to change from time to time.
