Concerning : Usage Fee of Meta Trader 5

Sehubungan dengan implementasi Meta Trader 5 maka PT Bursa Komoditi dan Derivati Indonesia (BKDI) dan PT Indonesia Clearing House (ICH) menetapkan sebagai berikut:

In regard with the implementation of Meta Trade 5 then PTIndonesia Commodity and Derivatives Exchange ("ICDX") and PT Indonesia Clearing House ("ICH") provide confirmation as following:

**I. BIAYA PENGGUNAAN**

**I. USAGE FEE**

1. Biaya Penggunaan Meta Trader 5 yang selanjutnya akan dihitung mulai tanggal 01 Januari 2020 adalah sebesar:

1. The fee for using Meta Trader 5, hereinafter referred to as "Usage Fee", shall be amounting of:

No No	Biaya Penggunaan	Usage Fee
1	0 - 100 IDS = \$ 100/Bulan	0 - 100 IDS = \$ 100/Month
2	101 t 500 IDS = \$ 400/Bulan	101 t 500 IDS = \$ 400/Month
3	501 t 1000 IDS = \$ 600/Bulan	501 t 1000 IDS = \$ 600/Month
4	1001 t 2000 IDS = \$ 1200/Bulan	1001 t 2000 IDS = \$ 1200/Month
5	2001 t 3000 IDS = \$ 1500/Bulan	2001 t 3000 IDS = \$ 1500/Month
6	>3001 = \$ 500/1000 IDS/Bulan	>3001 = \$ 500/1000 IDS/Month

2. Biaya yang dikenakan untuk 1 bulan penuh bagi setiap Nomer Account yang aktif sampai hari terakhir tiap bulannya.

2. Charges shall be for 1 full month for each active Nomer Account as at the last day of the month.

3. Bagi Broker yang baru menggunakan Meta Trader 5, tidak akan dikenakan biaya Penggunaan selama 2 bulan sejak aktivasi, untuk bulan ke-3 dan berikutnya akan dikenakan Biaya sesuai yang tertera diatas.

3. Brokers who are new to Meta Trader 5 will not be charged a Usage Fee for 2 months from activation of meta manager, for the 3rd month and the following will be charged as stated above.

4. BKDI akan menerbitkan invoice pada tanggal 10 setiap bulannya untuk biaya bulan sebelumnya dan Broker wajib melakukan pembayaran ke BKDI paling lambat 15 (Lima Belas) hari dari tanggal invoice. Akses Meta 5 otomatis akan dihentikan sementara sampai Broker memenuhi kewajibannya.

4. ICDX will issue invoice at the 10th of every month for the previous month charge and Broker has to pay to ICDX not more than 15 (fifteen) days from the date of the invoice. The Meta 5 access of the member shall temporary disable until the charge amount

5. 3 (tiga) ID pertama tidak dikenakan biaya, ID ke-4 (empat) sampai dengan 100 otomatis akan dikenakan biaya sesuai dengan ketentuan di atas.

settled by member if not paid within stipulated time.

5. The first 3 (three) IDs are free of charge, the (four) to 100 ID will automatically be charged according to the above conditions.

## II. KETENTUAN LAIN

1. Surat Edaran Bersama ini berlaku efektif sejak tanggal 28 Desember 2020.
2. Dengan berlakunya Surat Edaran Bersama ini, maka SEB No 255/SEB/BKIDCH/XII/2020 tentang Biaya Penggunaan Meta Trader 5 dinyatakan tidak berlaku lagi.
3. Ketentuan-ketentuan dalam Surat Edaran Bersama ini dapat diubah dari waktu ke waktu dan perubahan-perubahan tersebut akan diterbitkan dalam SEB.

## II. MISCELLANEOUS

1. This Joint Circular shall be effective on 28<sup>th</sup> December 2020.
2. On the effective date of this Joint Circular, Then SEB No. 255/SEB/BKIDCH/XII/2020 about Usage Fee of Meta Trader 5 shall be ceased to effect.
3. Provisions as referred to in this Joint Circular are subject to change from time to time and Changes will be issued in SEB.
