Dalam rangka meningkatkan volume transaksi Kontrak GOFX yang telah diluncurkan maka Bursa dan Lembaga Kliring memberikan insentif bagi Anggota Bursa dan/atau Anggota Kliring (bersama-sama disebut sebagai "**Anggota**") guna mendorong para Nasabah untuk melakukan transaksi pada kontrak GOFX. BKDI dan ICH dengan ini menetapkan ketentuan mengenai perpanjangan insentif biaya transaksi sebagai berikut:

In order to increase the volume of GOFX Contract transaction that have been launched, the Exchange and Clearing House grants incentive for Exchange Members and/or Clearing Members (together hereinafter referred to as the "**Members**") in order to encourage Customers to make transactions in GOFX Contract. ICDX and ICH hereby stipulate the extension of transaction fee incentives as follows:

**I. KETENTUAN UMUM**

Skema insentif biaya transaksi dalam Surat Edaran Bersama ini hanya diberlakukan bagi Anggota yang melakukan transaksi pada:

- Kontrak Gulir Harian Emas US Dollar (GOLDUD); dan
- Kontrak Mata Uang Asing (FOREX); selanjutnya disebut dengan "**Kontrak GOFX**".

**II. SKEMA INSENTIF**

BKDI dan ICH dengan ini menetapkan ketentuan pemberian insentif yang diperpanjang bagi Anggota sebagai berikut:

- Anggota dibebaskan dari pembayaran biaya transaksi kontrak GOFX sampai dengan 28 September 2018;
- Anggota juga diberikan potongan biaya transaksi dari 1 Oktober 2018 sampai dengan 30 November 2018, sebagai berikut:

**I. GENERAL PROVISION**

Transaction fee incentive scheme as stipulated in this Joint Circular is only applicable for Members who transact in:

- USD Gold Daily Rollover Contract (GOLDUD); and
- Foreign Currency Contract (FOREX); hereinafter referred to as "**GOFX Contract**".

**II. INCENTIVE SCHEME**

ICDX and ICH hereby stipulate the provision of incentives to be extended to the Members as follows:

- Members are exempt from payment of GOFX Contract transaction fee up to 28<sup>th</sup> September 2018;
- Members are also given rebate transaction fee from 1<sup>st</sup> October 2018 until 30<sup>th</sup> November 2018 as follows:
