**Concerning : Usage Fee of Meta Trader 5**

Sehubungan dengan implementasi Meta Trader 5 ("Meta5"), maka PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") dan PT Indonesia Clearing House ("ICH") menetapkan sebagai berikut:

In regard with the implementation of Meta Trader 5 ("Meta5"), then PT Indonesia Commodity and Derivatives Exchange ("ICDX") and PT Indonesia Clearing House ("ICH") provide confirmation as following:

**I. BIAYA PENGGUNAAN 'Meta Trader 5'**

**I. USAGE FEE 'Meta Trader 5'**

1. Biaya Penggunaan Meta Trader 5 yang selanjutnya disebut "Biaya" terhitung mulai tanggal 01 Desember 2020 adalah sebesar:

1. The fee for using Meta Trader 5, hereinafter referred to as "Fee" starting 1<sup>st</sup> December 2020 shall be amounting of:

No No	Biaya Penggunaan	Usage Fee
1	0 - 100 IDS = \$ 100/Bulan	0 - 100 IDS = \$ 100/Month
2	101 - 500 IDS = \$ 400/Bulan	101 - 500 IDS = \$ 400/Month
3	501 - 1000 IDS = \$ 600/Bulan	501 - 1000 IDS = \$ 600/Month
4	1001 - 2000 IDS = \$ 1200/Bulan	1001 - 2000 IDS = \$ 1200/Month
5	2001 - 3000 IDS = \$ 1500/Bulan	2001 - 3000 IDS = \$ 1500/Month
6	>3001 = \$ 500/1000 IDS/Bulan	>3001 = \$ 500/1000 IDS/Month

2. Bagi Broker yang baru menggunakan Meta Trader 5, tidak akan dikenakan biaya Penggunaan selama 2 bulan sejak aktivasi, untuk bulan ke-3 dan berikutnya akan dikenakan Biaya sesuai yang tertera diatas.
3. BKDI akan menerbitkan Invoice pada tanggal 10 setiap bulannya untuk biaya bulan sebelumnya dan Broker wajib melakukan pembayaran ke BKDI paling lambat 15 (Lima Belas) hari dari tanggal invoice. Akses ke Meta5 otomatis akan dihentikan sementara sampai Broker memenuhi kewajibannya.

2. Brokers who are new to Meta Trader 5 will not be charged a Usage fee for 2 months from activation, for the 3rd month and the following will be charged as stated above.
3. ICDX will issue invoice at 10<sup>th</sup> every month for the previos month charge and Broker has to pay through ICDX not more than 15 (fifteen) days from the date of the invoice. The Meta5 access of the member shall be temporary disable until the charge amount is settled by member if not paid within stipulated time.

**II. KETENTUAN LAIN**

1. Surat Edaran Bersama ini berlaku efektif sejak tanggal 01 Desember 2020
2. Ketentuan-ketentuan dalam Surat Edaran Bersama ini dapat diubah dari waktu ke waktu dan perubahan tersebut akan diterbitkan dalam SEB.
